Background and Context

SBDC is not your typical South Asian dance company. We are pioneers. We are innovators. Whether it be through retelling iconic works in the repertoire of productions such as Swan Lake, choreographing works like Together We Can to raise awareness of Climate Change to new audiences, or bringing Kathak to audiences at world famous venues such as the Royal Albert Hall, SBDC is always reinventing how Kathak dance is seen by the world.
